- 2) Customer understands that this agreement shall be void if repairs are made by anyone not so authorized by Laser Tech Solutions.
- 3) Any supplies not covered in this contract and purchased by the customer, must be Laser Tech Solutions recommended supplies. The use of non recommended supplies will void this contract,
- 4) This agreement includes interim calls, during normal business hours, as reasonably requested, required by causes other than carelessness or improper handling and use of this equipment, excluding damage caused by fire, lightning, power surges, riots, or acts of God. Laser Tech Solutions approved surge protectors are required an any damage caused with a non approved surge protector will be the responsibility of the customer.
- 5) No modification or amendment to this agreement will be binding unless in writing and signed by an officer of Laser Tech Solutions.
- 6) The transfer of equipment covered by this agreement to another location by persons other than LTS employees will exclude it from the terms of this agreement if a damage is caused during the transfer. Also, service rates on equipment transferred to a different area within our service area during the term of this agreement will be adjusted to the rate for the new area.
- 7) The term of this agreement is for a period of one year (unless otherwise specified) and is automatically renewed (at the sole discretion of LTS) at prevailing rates, unless terminated with 30 days written notice by either party.
- 8) Applicable sales, use or property taxes shall be assessed as prescribed by law
- 9) Laser Tech Solutions makes no warranties, express or implied, of merchantability, fitness for a particular purpose, performance, condition, capacity or otherwise, except as herein expressly set out. Laser Tech Solutions cannot be held liable as to the fitness of the above equipment from the manufacturer, only as service representative.

10) Customer shall indemnify and save Laser Tech Solutions harmless from any and all lightlifty, loss, damage, expense, cause of scilen, suits, claims for judgments arising from injuly to person or property resulting from actual or alleged use operation or transportation of the equipment or its location excondition after it has been delivered to the customer by LTS.
