Laser Tech Solutions approved surge protectors are required an any damage caused with a non approved surge protector will be the responsibility of the customer.

Also, service rates on equipment transferred to a different area within our service area during the term of this agreement will be adjusted to the rate for the new area.
- 7) The term of this agreement is for a period of one year (unless otherwise specified) and is automatically renewed (at the sole discretion of LTS) at prevailing rates, unless terminated with 30 days written notice by either party.
