WHEREAS, After graduation he went to Baylor University but left before graduating to join the Navy. After the Navy he attended Texas Christian University, West Texas State, Rock Hurst, North Texas State University and received CPCU (Chartered Property and Casualty Underwriter) designation from the American Institute for Property and Liability Underwriters, Inc., Bryn Mawr, PA. He married his high school sweetheart, Charlotte, right after graduation. After her passing, he married his wife Sharon. He has one son, Guy and one daughter Cyndi, and 3 grandchildren; and

WHEREAS, Dewey began his career with Employers Insurance of Texas as an investigator in 1956 and after 30 years, he retired. He has been a past president, chairman and member of numerous local businesses, professionals, church, and civic affiliations, and has spent many years working with First United Methodist Church of Cleburne, Nolan River Country Club, Cleburne Ex-Students Association, Planning and Zoning Commission, Johnson County Committee on Aging, Cleburne Kiwanis Club, Christian Businessmen's Club, United Way of Johnson County, Green Thumb Garden Club, Longhorn Council of Boy Scouts of America, Tuesday Forum, Annexation Board, Cleburne Athletic Booster Club, and Johnson County Advisory Board for Hill College along with numerous other organizations; and
