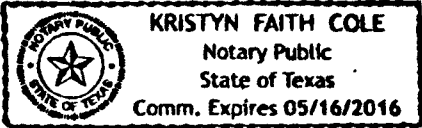

251.004 COMMISSIONER AS ROAD SUPERVISORS

- I. County Commissioners in Johnson County are the road supervisors.

251.005 COMMISSIONERS ROAD REPORT

- I. For Print out of roadway conditions including bridges & culverts, see "Attachment A"
- II. \$587,605.00 is the amount of money reasonably necessary to provide paving, seal coating, patching, oiling and adding of base material and maintenance of Precinct 2's public roadways.
- III. During this fiscal year, Precinct 2 replaced approximately 140 traffic control devices, signs. At this date we are not aware of, nor have any report of any defaced or torn down traffic control devices.
- IV. Developers are constructing approximately 2 miles of new roadways in subdivisions in Precinct 2.
- V. Precinct 2 has budgeted \$10,000.00 for the maintenance and improvements necessary to keep bridges and culverts in good condition.

251.07 CLASSIFICATION OF COUNTY ROADS

- I. All public roadways in Precinct 2 will be classified as third class roadways, having less than 40-feet of roadway and some have less than 20-feet of roadway.
