

Payor shall be notified, in writing, of any change in ownership, decimal interest or payment address. All such changes shall be effective the first day of month following receipt of such notice.

This Division Order does not amend any lease or operating agreement between the undersigned and the lessee or operator or any other contracts for the purchase of oil or gas.

In addition to the terms and conditions of this Division Order, the undersigned and Payor may have certain statutory rights under the laws of the state in which the property is located.

Requirement # 1

Most property owners in your area are subject to a Deed of Trust, or mortgage. If an oil and gas lease is executed after the date of the mortgage, the mortgage company must subordinate the Deed of Trust to the oil and gas lease. Please read below for more information on how to obtain a mortgage subordination and avoid the placement of your interest into suspense. If there is no current mortgage on your property, please provide us with a recorded copy of the release, or sign the statement of exemption below and return either the release, or statement with your division order.

A subordination agreement gives the oil and gas well operator the authority to distribute royalties directly to the property owner, as well as protect the oil and gas well operator's rights under the oil and gas lease. Attached hereto is a blank subordination form to be filled out by you and/or your mortgage company. It should be executed by an authorized representative of the mortgage company and returned to Chesapeake. We ask that you please contact your mortgage company as soon as possible to begin this process so you do not experience any inconvenience in royalty suspension.

Regardless of any encumbrances on your property, you will receive royalties once you have executed and returned your division order to Chesapeake. However, if after thirty (30) days from the date of this notice we have not received a subordination agreement from your mortgage company, or a release, or a signed statement of exemption, we must, unfortunately, place your royalties in suspense, pending receipt of the requested documents. Please be sure to sign your division order in the presence of a witness and return the division order to Chesapeake either by regular mail at the address shown on the division order, or by fax to 405-879-9563, at your earliest convenience. You may return your division order prior to your subordination form.
