DEPUTY CLIFTON TAYLOR MEMORIAL CHAIR

- WHEREAS, On January 14, 2008. Clifton Taylor began his career with the Johnson County Sheriff's Office, where he quickly became a popular and respected deputy; and
- WHEREAS, On April 23, 2011, Deputy Taylor, along with other deputies, responded to a disturbance call on Eagle Court near Venus, Texas; and
- WHEREAS, Upon arriving on the scene, the deputies began looking for a male subject who was involved in the disturbance. While conducting the search, Deputy Taylor opened a door on a shed and was met with gunfire, which resulted in him being struck and later succumbing to his wounds. The other deputies returned fire and killed the suspect; and
- WHEREAS, On April 24, 2011, Deputy Taylor's radio number 156 and badge number 1822 were retired; and
- WHEREAS, On October 12, 2015, an organization by the name of "Saving a Hero's Place" presented a hand-made memorial chair in Deputy Taylor's honor to the Johnson County Sheriff's Office; and
- WHEREAS, Deputy Taylor's Memorial Chair was placed in the Johnson County Sheriff's Office Patrol Deputies' Room where it remains today.

NOW THEREFORE, BE IT RESOLVED THAT I, Roger Harmon, County Judge of Johnson County, we the Commissioners of the four Precincts in Johnson County, and Bob L. Alford, Sheriff of Johnson County, do hereby proclaim that Deputy Clifton Taylor's Memorial Chair will remain as permanent property of the Johnson County Sheriff's Office, and will remain in the Patrol Deputies' Room from this day forward to be a daily reminder to his co-workers, ensuring that Deputy Taylor will always have a place saved for him at the Johnson County Sheriff's Office.
