Dear Mr. Humphries:

As you know Johnson County is in the process of transitioning to new software and information technology services. Consequently we will not be utilizing Grave Humphries Stahl, Ltd for collection of delinquent fines and fees on behalf of the Justice of the Peace Courts in Johnson County, Texas. Johnson County previously sent to you a letter dated January 26, 2016 notifying you that Johnson County was terminating the contract effective March 31, 2016. Due to unforeseen circumstances, Johnson County wants to continue the current contract until June 30, 2016. According to Dan Milam, IT Director for Jonson County, he had a conversation with Scott Stahl who indicated that GHS is agreeable to continue the current contract to June 30, 2016.

Pursuant to the terms of the contract executed June 22, 2015 between Johnson County Texas and Graves Humphries Stahl, Ltd. (GHS), Johnson County hereby provides notice of termination of the agreement for collection services effective June 30, 2016. In accord with the provisions of the Contract, GHS will not "pull data" or receive additional accounts after June 30, 2016 for the collection of delinquent court fines and fees pertaining to Justice of the Peace cases. GHS will have a period of 6 months following June 30, 2016 to "work the cases" which became delinquent prior to June 30, 2016 and for which data or "the case" was transmitted to GHS prior to June 30, 2016.
