The 69th Annual Statewide Training Conference, conducted by the Texas Veterans Commission (TVC), will be held at the Hyatt Regency San Antonio, 123 Losoya St., San Antonio, Texas 78205. Hotel information is attached.

TVC sent a letter on June 28, 2016, via email, to your County Judge/Commissioners Court informing them of the conference and encouraging support for your attendance. Section 434.038(a), Texas Government Code, requires VCSOs to attend Commission Training to maintain certification in order to remain in office. Certification is also required for those wishing to participate in the Commission's Accreditation Program.

#### What You Need To Know:

- The designated travel day is Monday, September 5, 2016, which is Labor Day. If you are unable to travel on county business on a holiday, please arrive no later than Tuesday, September 6, 2016, at 1:00 pm. This will reduce their annual training by 4 hours. If you decide you cannot arrive on Monday but have already secured your reservation, it is YOUR responsibility to cancel Monday night's reservation. If you do not cancel, you will be responsible for the expense. TVC will not reimburse for a no-show.
- Opening Session will begin 8:00 a.m. Tuesday, September 6, in the Regency Ballroom on the Ballroom Level (2<sup>nd</sup> Floor). Classroom training will begin immediately following the opening session and continues throughout the week with adjournment around noon on Friday, September 9, 2016.

#### **HOTEL RESERVATION DETAILS**

- All VCSOs attending the Certification or Accreditation Training (not Initial) are responsible for securing their own hotel reservations. Newly appointed VCSOs who plan on attending initial training, please DO NOT contact the hotel. Contact Nancy Gamroth at TVC Headquarters at nancy.gamroth@tvc.texas.gov as soon as possible.
- Hotel reservations are available on a <u>first-come</u>, <u>first-served</u> basis by calling (210) 222-1234 and using Event Code <u>TXVET2016</u> or online <u>HERE</u>. Click on the "*Hotel Reservation*" button. We encourage you to reserve your rooms and register as soon as possible.
- The room rate for single or double occupancy, which includes complimentary Wi-Fi and a refrigerator in each guest room, is as follows:

• The Government rate will NOT be available prior to opening or anytime following adjournment.

- Self-parking is at a minimum and we encourage carpooling. While valet parking is available, TVC will not reimburse for valet parking. We encourage you to carpool if possible.
- For those of you who will be flying into San Antonio, the hotel does provide hotel shuttle service at a cost of \$32/round trip. TVC will be researching the availability of a less expensive service and will notify you of our findings. Either way, you will be responsible for making your own reservations for shuttle service through the hotel. Shuttle service is not a reimbursable expense.
- Check-in at each facility begins at 3:00 p.m. and check-out at each facility is 11:00 a.m. Please note that you
  may need to present a credit card upon check-in to cover incidentals, even if you do not plan on having extra
  expenses (room service, etc.).

#### **CONFERENCE REGISTRATION DETAILS**

- Conference Registration is necessary whether you are staying at the Hyatt, choose to stay elsewhere or are local to the area. Registration should be done as soon as possible online HERE. Click on the "Conference Registration" button. Monday, August 8, 2016, is the absolute cut-off date for both the hotel reservation and conference registration.
- When you register, be sure to note in the area provided any special needs you require in your hotel room and/or classroom to include auxiliary aids or services, e.g., roll-in shower, room on lowest floor available, room near elevator, interpreter for hearing impaired, reader, large print or Braille, etc. TVC will review your requests and make every effort to accommodate them, including king/queen/double beds, etc., however we cannot guarantee it. Remember, each room is equipped with a refrigerator. Make sure you request these needs when you secure your reservation as well.

#### CONFERENCE CHECK-IN UPON ARRIVAL

• Conference check-in will be held in the Los Rios Foyer on Monday, September 5, 2016, from 2:00 to 7:00 p.m. and begin again on Tuesday morning at 6:45 a.m. The registration desk will remain open throughout the Conference.

#### <u>PLEASE NOTE</u>

- Only coffee and water will be provided in the mornings. No afternoon refreshments. There are kiosks in the hotel for snacks and additional beverages and restaurants available on the River Walk that do serve breakfast.
- If members of your staff or members of veterans' organizations or other agencies wish to attend the TVC training, please have them contact Nancy Gamroth at <a href="maintenancy.gamroth@tvc.texas.gov">nancy.gamroth@tvc.texas.gov</a> prior to securing a hotel reservation or registering for training. There is a form they must complete prior to training.
- During this year's conference, you will be given the opportunity to attend sessions that you believe will assist you in providing services to veterans. In the coming weeks, you will be provided with a session schedule, be asked to select the sessions you wish to attend, and return those selections to us so that we can ensure you have seat available.

### **Dear Veterans County Service Officers and Assistants,**

Due to the increase in the GSA rate after we contracted a the \$115 rate, the hotel rate will not be \$120 per night. We do not have control over this rate as we must actually contract at the <u>current rate according to GSA</u>.

Also, the parking is contracted with Central Parking across the street from the Hyatt at \$14/night. This is separate from the hotel contract. You may be quoted \$39/day (which is Hotel's valet rate, by the way) but the rate will be \$14 and the garage will be accessed by your hotel room key and billed to your room. In and out privileges are included, however space is limited!!!

We do encourage you all to carpool if possible!

PLEASE NOTE: TVC does not reimburse for parking when it is NOT included in the room rate unless you are attending Initial Training. The reason you were informed of the rate is because some of you were quoted \$39 a night when you made your hotel reservation. You WILL get our contracted rate at the Central Parking Garage of \$14/night as opposed to the \$39 rate.

TVC also will not cover shuttle service expenses unless you are attending Initial Training.
