“VETERANS RECOGNITION & APPRECIATION DAYS”





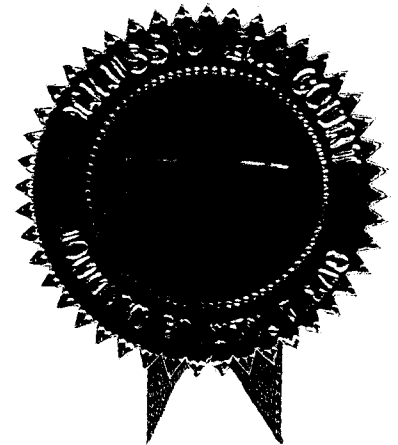
