- WHEREAS, Bob Alford has served the citizens of Johnson County and the entire community with great leadership, dedication, integrity and compassion and is a man of strong Christian faith that shows in his day to day life; and
- WHEREAS, On December 31, 2016 Bob Alford is retiring as Sheriff of Johnson County and from a law enforcement career of more than 45 years;
