

Hon. Judge and Commissioners:

Section 614.051 of the Government Code states that an honorably retired peace officer may purchase the firearm that had been previously issued to him(her) for an amount not to exceed fair market value. In order for deputies retiring at the end of this calendar year to proceed with the purchase of the county-issued firearm, the following prices are considered to be in compliance with the statute.

Sig Sauer P320, any caliber	\$300
Sig Sauer P226, .357 Sig caliber	\$225

The prices reflect the price the County would obtain for the firearms if selling them to a licensed firearms dealer.
