

JOHNSON COUNTY BANK DEPOSITORY CONTRACT RENEWAL

This JOHNSON COUNTY BANK DEPOSITORY CONTRACT RENEWAL hereinafter called "DEPOSITORY CONTRACT RENEWAL" is made and entered into on the date last herein written by and between JOHNSON COUNTY, TEXAS, hereinafter called "COUNTY", and FIRST FINANCIAL BANK, N. A., a national banking association organized under the laws of the United States and authorized by law to do banking business in Johnson County, Texas and now conducting such business in said County, hereinafter called "BANK", and is as follows:

I.

On May 28, 2013, pursuant to Section 116.021, Texas Local Government Code, COUNTY and BANK entered into a contract titled JOHNSON COUNTY BANK DEPOSITORY CONTRACT (the "DEPOSITORY CONTRACT") for a four year period beginning June 1, 2013 and continuing until May 31, 2017.

II.

Pursuant to Section 116.021, Texas Local Government Code, on the expiration of the DEPOSITORY CONTRACT, the DEPOSITORY CONTRACT may be renewed for two years under terms negotiated by the Commissioners Court.

III.

COUNTY and BANK desire to renew the DEPOSITORY CONTRACT for two years, beginning June 1, 2017 and continuing until May 31, 2019.

IV.

COUNTY AND BANK agree that this DEPOSITORY CONTRACT RENEWAL will be under the same terms and conditions as set forth in the DEPOSITORY CONTRACT and Exhibit "A", Johnson County Depository Pledge Contract with Addendum; Exhibit "B", Johnson County Collateral Security Agreement; and Exhibit "C", First Financial Bank, N. A.'s Bid for Depository Contract, RFP 2013-307 which were attached to the DEPOSITORY CONTRACT and incorporated fully as if recited in the DEPOSITORY CONTRACT verbatim; however, to the extent that any provision in Exhibit "A", Exhibit "B", Exhibit "C" or this DEPOSITORY CONTRACT RENEWAL conflicts with any provision herein, this DEPOSITORY CONTRACT RENEWAL

will control.

IN TESTIMONY OF WHICH, THIS DEPOSITORY CONTRACT RENEWAL has been executed by the COUNTY and BANK as of the date stated below. The provisions of this contract shall be binding upon and inure to the benefit of the heirs, executors, administrators, successors and assigns of the parties.
