ORDER RATIFYING PROPERTY TAX INCREASE FOR THE 2017 TAX YEAR

WHEREAS, the Commissioners Court of Johnson County, Texas has approved the Annual Budget for Johnson County for Fiscal Year 2017-2018; and

WHEREAS, the Commissioners Court of Johnson County, Texas has adopted a tax rate for the 2017 Tax Year to fund the Annual Budget for Johnson County for Fiscal Year 2017-2018: and

WHEREAS, the adoption of said Annual Budget for Johnson County for Fiscal Year 2017-2018 will require raising more revenue from property taxes than in the previous year; and
