**DESIGNATION AND INSTALLATION OF NO PARKING SIGNAGE ON EACH SIDE OF THE ROAD FOR THE FIRST 1000 FEET OF CR 711A (ALSO KNOWN AS COLLINS RD) FROM THE INTERSECTION OF CR 711A AND FM 731 IN JOHNSON COUNTY, TEXAS - PRECINCT #4 (CR 711A/COLLINS RD IS LOCATED ADJACENT TO THE NICHOLS MIDDLE SCHOOL CAMPUS IN JOSHUA ISD)**
