## FIRST AMENDMENT TO AGREEMENT BETWEEN JOHNSON COUTY AND MULTI-BANK SECURITIES, INC. FOR THE PURCHASING OF CERTIFICATES OF DEPOSIT WITH JOHNSON COUNTY PUBLIC FUNDS

This First Amendment to Agreement Between Johnson County and Multi-Bank Securities, Inc. for the Purchasing of Certificates of Deposit With Johnson County Public Funds (the "Amendment") is made and entered into by and between the Johnson County, Texas, a political subdivision of the State of Texas ("County") acting herein by and through its duly authorized Commissioners Court, and Multi-Bank Securities, Inc. ('Multi-Bank"), individually referred to as a "Party," collectively referred to herein as the "Parties" and is an amendment to the Agreement Between Johnson County and Multi-Bank Securities, Inc. for the Purchasing of Certificates of Deposit With Johnson County Public Funds (the "Agreement") between County and Multi-Bank currently in effect.

WHEREAS, on November 23, 2015 Johnson County approved the Agreement Between Johnson County and Multi-Bank Securities, Inc. for the Purchasing of Certificates of Deposit With Johnson County Public Funds (hereinafter referred to as the "Agreement"); and

WHEREAS, at the time the Agreement was executed, Debbie Rice was the duly elected County Treasurer of Johnson County and authorized and empowered by the Agreement to purchase certificates of deposit; and

**WHEREAS**, Debbie Rice resigned as County Treasurer of Johnson County effective December 31, 2017; and

WHEREAS, Kathy Blackwell was appointed as County Treasurer by the Commissioners Court of Johnson County to fill the unexpired term of Debbie Rice; and

WHEREAS, Kathy Blackwell on January 2, 2018 took the oath of office and posted the requisite bond and has duly qualified as County Treasurer of Johnson County, Texas.

FIRST AMENDMENT TO AGREEMENT BETWEEN JOHNSON COUNTY AND MULTI-BANK SECURITIES, INC. FOR THE PURCHASING OF CERTIFICATES OF DEPOSIT WITH JOHNSON COUNTY PUBLIC FUNDS

**NOW, THEREORE**, in consideration of the mutual promises and covenants contained herein, Johnson County, a political subdivision of the State of Texas, (hereinafter referred to as "County") and Multi-Bank Securities, Inc., (hereinafter referred to as Multi-Bank), agree and understand as follows:

- 1. Paragraph number 4 of the Agreement is changed to state: Kathy Blackwell is the duly appointed County Treasurer of Johnson County and is an Authorized Person of Johnson County for investment purposes.
- 2. Paragraph Number 6 of the Agreement is changed to state: Kathy Blackwell and J. R. "Kirk" Kirkpatrick are authorized and empowered for and on behalf of County for the purpose of purchasing, investing in, or otherwise acquiring, selling, possessing, transferring, exchanging, pledging, or otherwise disposing of or realizing upon, and generally dealing with certificates of deposit.
- 3. This First Amendment shall in no way affect or modify any other terms and conditions of the aforementioned Agreement.

IN WITNESS WHEREOF, intending to be legally bound, the Parties have caused their authorized representative to execute this Agreement. Each representative whose signature appears on this Agreement represents and does hereby certify that they have the authority to enter into this Agreement for their represented Party.
