PROCLAMATION

VETERANS RECOGNITION & APPRECIATION DAYS

- WHEREAS, we pay tribute to our veterans, we are mindful that no ceremony or parade can fully repay that debt. We remember that our obligations endure long after the battle ends, and we make it our mission to give them the respect and care they have earned.
