The North Central Texas Council of Governments' Criminal Justice Policy Development Committee (CJPDC) provides overall policy guidance to our Criminal Justice Program and is responsible for setting region-wide criminal justice priorities.

- Encouraging public awareness of criminal justice matters.

Committee members read and score many justice-related grant applications, travel to NCTCOG offices 7-8 times a year for meetings, serve up to three years, and should have internet/email access. March and April are usually the busiest months for the committee; in addition, there will be at least two fall meetings.
