Dear Mr. Treon,

In regards to our phone conversation around March 7<sup>th</sup>, 2017 and the above referenced accounts you asked about the exemption on the Venus Prison since it was owned by the State of Texas. We agreed that the prison which is account 126.0134.00179 would be exempt for the 2017 tax year. However, we also talked about instead of paying the taxes as had been done in the past that you would make a payment in lieu of taxes / a gift payment to the taxing entities no later than December 31<sup>st</sup> of the tax year in the following amounts.

ESDI	\$8,232.00

Total	\$392,000.00

This payment would be in recognition that the taxing units will still be extending services to the prison and its workers. We also discussed account 126.5544.01920 which is your personal property account for equipment that MTC-Sanders Ester CC owns and that you will pay taxes on this account when you receive your tax statement in October of the tax year.
