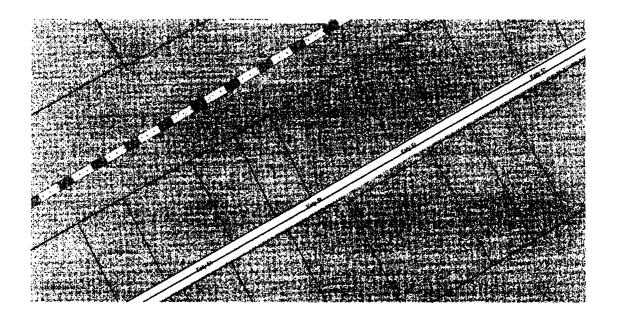
We understand that if we are awarded the bid, we will:
