**COMMISSIONERS COURT AUTHORIZING THE COUNTY ATTORNEY TO
SUBMIT A COMPLETED QUESTIONNAIRE AND APPLICABLE
ATTACHMENTS TO THE TEXAS COMPTROLLER OF PUBLIC ACCOUNTS
(COMPTROLLER) FOR REVIEW AND APPROVAL OF INITIAL CONTINGENT
FEE LEGAL SERVICES CONTRACT AND/OR RENEWAL OR AMENDMENT
OF SUCH CONTRACT PURSUANT TO SECTION 403.0305 OF THE TEXAS
GOVERNMENT CODE**

The Johnson County Commissioners Court met on January 30, 2019 for the consideration of an Amended Attorney's Retainer Contract of representation with Ferrer Poirot & Wansbrough, the MacLean Law Firm, PC, and Fears Nachawati, for Opioid Litigation based upon a contingent fee. The Commissioners Court finds that the County must submit a completed questionnaire and all applicable attachments to the Texas Comptroller of Public Accounts (Comptroller) for review and approval of initial contingent fee legal services contract and/or renewal or amendment of such contract pursuant to Section 403.0305 of the Texas Government Code.

A motion was made by Commissioner Stringer, Pct. #3 and seconded by Commissioner Howell, Pct. #2 that: "The Commissioners Court authorize the County Attorney to submit a completed questionnaire and all applicable attachments to the Texas Comptroller of Public Accounts (Comptroller) for review and approval of initial contingent fee legal services contract and/or renewal or amendment of such contract pursuant to Section 403.0305 of the Texas Government Code."
