# RESOLUTION OF JOHNSON COUNTY, TEXAS REGARDING CLAIMS PAYMENT ACCOUNT WITH FIRST FINANCIAL BANK TO PAY JOHNSON COUNTY INDIGENT HEALTH CARE CLAIMS

- WHEREAS, Johnson County is a political subdivision of the State of Texas; and
- WHEREAS, Johnson County Indigent Health Care is responsible for paying medical claims for individuals residing in Johnson County, Texas who are qualified as indigent; and
- WHEREAS, Johnson County has contracted with WebTPA to assist Johnson County with reviewing, processing and paying claims of individuals residing in Johnson County, Texas who are qualified as indigent; and
- WHEREAS, the County Treasurer and the County Auditor are proposing that Johnson County establish an account with First Financial Bank, Johnson County's Bank Depository, named the Claims Payment Account from which to pay medical claims for individuals residing in Johnson County, Texas who are qualified as indigent; and
- WHEREAS, Johnson County desires to provide First Financial Bank with the guidelines and procedures for how Johnson County will review, process and pay medical claims for individuals residing in Johnson County, Texas who are qualified as indigent; and
- WHEREAS, indigent health care claims will be reviewed and processed by WebTPA;

WHEREAS, VPay, through the automated clearinghouse network ("ACH"), will originate ACH entries to the Claims Payment Account in order to pay medical claims for indigent health as authorized by WebTPA, and only after approval by the Commissioners Court of Johnson County, Texas; and

WHEREAS, the authorized signatures for the Claims Payment Account will be limited to Kathy Blackwell, County Treasurer, and J.R. (Kirk) Kirkpatrick, County Auditor.

NOW, THEREFORE, BE IT RESOLVED THAT the Commissioners Court of Johnson County, Texas, passes this resolution to (1) establish an account with First Financial Bank named the Claims Payment Account from which to pay medical claims for individuals residing in Johnson County, Texas who are qualified as indigent, (2) approve WebTPA to review and process indigent health care claims for individuals residing in Johnson County, Texas who are qualified as indigent, (3) permit VPay, through the automated clearinghouse network ("ACH"), to originate ACH entries to the Claims Payment Account in order to pay medical claims for indigent health care as authorized by WebTPA and only after approval by the Commissioners Court of Johnson County, Texas; and (4) limit the authorized signatures for the Claims Payment Account to Kathy Blackwell, County Treasurer and J.R. (Kirk) Kirkpatrick, County Auditor.
