## AUTOMOBILE LIABILITY POINT SYSTEM FOR EXCLUSION OF DRIVERS

Excluded driver would have 12 points or more

Warned driver would have 8-11 points

**The following is a schedule of the points assessed for specific violations.**

12 points within the past 36 months

- Driving while intoxicated

6 points within the past 36 months

- Leaving the scene of an accident if property damage
- Driving while license suspended

4 points within the last 36 months

- At fault accidents
- Driving on the wrong side of the road
- Driving in wrong lane
- Turning from wrong lane
- Failure to control vehicle
- Illegal passing

3 points within the past 36 months

- Speeding and all other moving traffic violations

**Automatic Exclusion for the following:**

- Intoxication assault
- Intoxication manslaughter
- Leaving the scene of accident if death, serious bodily injury or injury
