BE IT KNOWN that on the 24<sup>th</sup> day of June 2019, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:02 A.M. with all members present, and following the Invocation led by Alicia Martinez, a visiting missionary from Nicaragua, and the Pledge of Allegiance, the following items, having been lawfully posted and filed for record in the Office of the County Clerk on June 20, 2019 at 1:03 P.M., were considered:

# IV. WELCOME VISITORS, ANNOUNCEMENTS & PRESENTATIONS

1. ANNOUNCEMENT: DUE TO THE JULY 4TH HOLIDAY, THE DEADLINE TO SUBMIT ITEMS FOR THE JULY 8, 2019 COMMISSIONERS COURT AGENDA WILL BE NOON ON MONDAY, JULY 1, 2019

County Judge, Roger Harmon announced that due to the July 4th Holiday, the Deadline to Submit Items for the July 8, 2019 Commissioners Court Agenda will be Noon on **Monday**, **July 1**, **2019**.

2. PRESENTATION FROM SPYGLASS GROUP, LLC ON VERIFICATION OF SAVINGS TO THE COUNTY

There being no representative from Spyglass Group, LLC present, County Judge, Roger Harmon addressed the Court in regards to Spyglass Group, LLC's Verification of Savings and the payment of \$50,000.00 to Spyglass for savings found by their audit. The Judge asked the Court if they wanted him to pay the invoice without hearing from Spyglass, or if they prefer him to wait until they do have a chance to discuss the audit and the County Attorney has had a chance to review the contract with Spyglass and their itemized audit.

The County Auditor, Kirk Kirkpatrick addressed the Court in order to clarify that the payment of \$50,000.00 is not an "advanced payment" as stated by the County Judge, but that it is payment for the services and findings from Spyglass's audit.

Commissioner Bailey, Precinct #1, Commissioner Woolley, Precinct #4 and County Attorney, Bill Moore commented in support of the Judge's decision to wait to pay the Invoice.

With the Court's permission the Judge stated he would not pay the \$50,000.00 until the County Attorney has had a chance to review the contract with Spyglass Group, LLC and the itemized report provided by their audit.

### V. <u>PUBLIC PARTICIPATION</u>

Patti Meier, Mayor of Cross Timber, Texas, addressed the Court in regards to bridge repair of a low water crossing on Cross Timber Rd. Mayor Meier asked for the Commissioners Court help with the cost of repair. She stated that they have gotten a couple of bids for the cost of repair and have sent that information to Commissioner Woolley, Precinct #4, who is working on a possible Inter-local Agreement. Mayor Meier referenced *Section 251.02* which allows the Commissioners Court to spend money to perform work if it's a connecting road or if it would benefit the County.

#### VI. PUBLIC HEARING

The Commissioners Court opened a Public Hearing at 9:21 A.M. to discuss:

# 1. REDUCE SPEED LIMIT TO 20 MPH ON PERCIFIELD TRAIL FROM HWY 67 TO CR 707 IN JOHNSON COUNTY, TEXAS-PRECINCT #4

There being no one from the Public wishing to speak, County Judge, Roger Harmon turned the discussion over to Commissioner Larry Woolley, Precinct #4.

Commissioner Woolley stated that this action is driven by the intersection of HWY 67 and I35. He stated the drivers are using Percifield Trail as a "get-a-round" or a "cut-through". Commissioner Woolley asked the Sheriff's Office to assess the road, and upon their recommendations, along with dialogue of the residents on Percifield Trail, Commissioner Woolley recommended that the reduction of the Speed Limit to 20 MPH would have the greatest impact.

The being no one else to speak, the Public Hearing was closed at 9:26 A.M.

The Commissioners Court opened a Public Hearing at 9:26 A.M. to discuss:

2. <u>DESIGNATION AND INSTALLATION OF "NO THRU TRUCKS" SIGNS ON CR 810 S FROM US 67 TO FM 3136 IN JOHNSON COUNTY, TEXAS-PRECINCT #4</u>

Tinker Williams, a resident on CR 810, addressed the Court in regards to the installation of "No Thru Trucks" signs on CR 810 S. She stated that their concerns were the number of 18-wheelers that use the road, and the damage that the 18-wheelers are doing to the road because of the weight of the trucks.

There being no one else from the Public wishing to speak, County Judge, Roger Harmon turned the discussion over to Commissioner Larry Woolley, Precinct #4. Commissioner Woolley stated that this action was driven by the residents of CR 810 S, and he did clarify that the "No Thru Trucks" signs would not affect "destination trucks"; which was a concern of a gentleman who owns a trucking company along CR 810 S. Commissioner Woolley asked the Sheriff's Office to assess the road for this proposal as well and stated that they agree that this action would be the appropriate measure to cut-down the traffic.

Commissioner Bailey, Precinct #1 commented that his concern is that there will still be trucks traveling on the road despite the "No Thru Trucks" signs because they do not know the local laws and because they are following a GPS route. Also, he stated that it is hard to police the road because some trucks will still use a "No Thru Trucks" road as a "cut-through", by exiting out the way they entered and acting as a "destination truck". Commissioner Bailey said he wanted to make the Public aware that even though the County puts the signs out, it is very hard to, not only police the road, but that the County has no recourse to get resources from the trucking companies to repair the road damage.

The being no one else to speak, the Public Hearing was closed at 9:35 A.M.
