COUNTY

- Commissioners Court approves a project and approves the precincts share in the work
- Commissioners Court approves the transfer of funds from 0100-5100-57XXX-GG to an applicable Construction fund
 - > Small project transfer to Fund 7050 (fund created to track small construction projects) and apply a project code
 - ➤ Large project transfer to a Capital Projects Fund 7XXX

County reimburses precinct for their portion of the work following the precinct actions below

R&B PRECINCT

- Execute precinct portion of the project
- Charge expenses through the precinct budget
- Keep a detailed record of salary and materials
- Invoice the county for reimbursement from the applicable construction funds, attaching all appropriate supporting documentation

EQUIPMENT USE

- Equipment owned by JOCO is housed at a precinct
- Precinct maintains the equipment out of the precinct budget
