#### 1. PUBLIC HEARING ON THE 2019-2020 BUDGET

There being no one from the public wishing to speak, County Judge, Roger Harmon turned the discussion over to the Members of the Court.

Commissioner Bailey, Precinct #1 commented about the controversy in regards to the increase in property valuations, but that word has finally gotten out that property valuations are not controlled by the Commissioners Court.

Commissioner Howell, Precinct #2 commented that due to the new growth the County has experienced, the Court was able to lower the tax rate. Commissioner Howell also noted that the County was one of the first entities in the area to announce early in the budget process that the Court was going to lower the tax rate.

Commissioner Woolley, Precinct #4 commented that the new growth does not count towards the rollback rate, but new growth in terms of new roofs and new business is what helped the County. He stated that since January 1, 2015 over 21,000 lots have been platted in the County. Commissioner Woolley also noted that the Court reduced the County's Debt Rate to less than \$0.01, and he was proud of the Court of being so conservative.

There being no one else wishing to speak, the Public Hearing was closed at 9:33 A.M.
