February 18, 2020 through February 28, 2020 is the period for early voting by personal appearance (Sec. 85.001). Any voter qualified to vote in the March 3, 2020, Primary Election is eligible for early voting by personal appearance.

Early voting by personal appearance will be conducted at all following locations:

Tuesday, February 18, 2020 – Friday, February 21, 2020 hours: 8:00 am until 5:00 pm.

Monday, February 24, 2020 - Friday, February 28, 2020 hours: 7:00 am until 7:00 pm.

Sunday, February 23, 2020, 11:00 am to 4:00 pm (excluding Venus Community Center)

Sec. 85.062 Texas Election Code

(2) The Commissioners court of a county with a population of 120,000 or more but less than 400,000 shall establish one or more early voting polling places other than the main early voting polling place in each Commissioners precinct containing territory covered by the election.

(Sec. 85.062 Código Electoral de Texas

(2) El Tribunal de Comisarios de un condado con una población de 120,000 ó más, pero menos de 400,000, establecerá al menos un centro de votación adelantada, además del centro primario de votación adelantada, en cada recinto de los comisarios que contiene territorio incluido en la elección.)
