

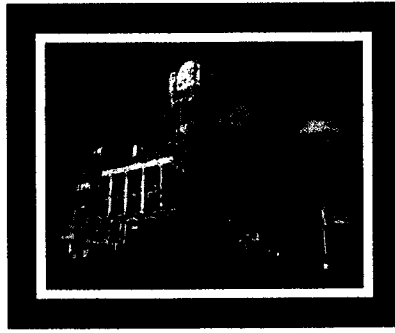

Volunteer Release and Waiver of Liability

This Release and Waiver of Liability executed on _____ by _____ (Volunteer) releases the Johnson County Texas Courthouse Museum (JCCM), a non-profit organization organized and existing under the laws of the State of Texas. The above named volunteer desires to provide volunteer services for the JCCM and engage in activities related to serving as a volunteer. Johnson County Texas Courthouse Museum (JCCM) as used herein includes the officers, officials and employees of JCCM; and Johnson County, Texas as used herein includes the officials and employees of Johnson County, Texas.

Volunteer understands that the scope of Volunteer's relationship with JCCM is limited to a volunteer position and that no compensation is expected in return for services provided by volunteer; that JCCM will not provide any benefits traditionally associated with employment to Volunteer; and the Volunteer is responsible for his/her own insurance coverage in the event of personal injury or illness as a result of Volunteer's services to JCCM.

1. Waiver and Release: I, _____, release, discharge and hold harmless JCCM and Johnson County, Texas from any and all liability, claims, and demands of whatever of nature. I understand and acknowledge that this Release discharges JCCM and Johnson County, Texas from any liability or claim that I may have against JCCM or Johnson County, Texas with respect to bodily injury, personal injury, illness, death, or property damage that may result from the service I provide to JCCM or occurring while I am providing volunteer services.
2. Insurance: Further I understand that JCCM nor Johnson County, Texas does not assume any responsibility for or obligation to provide me with financial or other assistance, including but not limited to medical health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of JCCM and Johnson County, Texas beyond what may be offered freely by JCCM or Johnson County, Texas in the event of injury or medical expenses incurred by me.
3. Other: As a volunteer, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Texas and that this Release shall be governed by and interpreted in accordance with the laws of the State of Texas. I agree that in the event any clause or provision of this Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.
