County Judge, Roger Harmon welcomed those in the audience and thanked them for their presence.

## 1. <u>PRESENTATION OF PROCLAMATION FOR CHILD ABUSE PREVENTION MONTH</u>

County Judge, Roger Harmon read the Proclamation for Child Abuse Prevention Month for Court Record and he, along with the other Members of the Commissioners Court, proclaimed the month of April, 2020 as, "Child Abuse Prevention Month." The Proclamation was presented to Tammy King, Executive Director of the Children's Advocacy Center.

Kenny Frazier, owner of the Crazy Gun Dealer addressed the Commissioners Court in regards to the COVID-19 shut downs. Mr. Frazier stated he was trying to be proactive in the event of a more restrictive emergency Declaration and he urged the Commissioners Court, in such an event, that they consider gun dealers an essential business in order to provide people with guns and ammo to protect themselves.
