### EARLY VOTING POLLING LOCATIONS JULY 14, 2020 DEMOCRATIC PRIMARY RUN-OFF ELECTION (CENTROS PARA VOTACIÓN ADELANTADA 14 DE JULIO DEL 2020 ELECCIÓN PRIMARIA DEMOCRÁTICA DE SEGUNDA VUELTA)

June 29, 2020 through July 10, 2020 is the period for early voting by personal appearance excluding Friday July 3, 2020 and Saturday July 4, 2020. (Sec. 85.001). Any voter qualified to vote in the July 14, 2020, Democrat Primary Run-Off Election is eligible for early voting by personal appearance.

Early voting by personal appearance will be conducted at all following locations:

Monday, June 29, 2020 – Thursday July 2, 2020 hours: 8:00 am until 5:00 pm.

Monday, July 6, 2020 – Friday, July 10, 2020 hours: 7:00 am until 7:00 pm.

#### **Sec. 85.062 Texas Election Code**

(2) The Commissioners court of a county with a population of 120,000 or more but less than 400,000 shall establish one or more early voting polling places other than the main early voting polling place in each Commissioners precinct containing territory covered by the election.
