- WHEREAS, American Legion Post 50, American Legion Auxiliary Unit 50, Squadron 50 Sons of the American Legion and Chapter 1867 of The Military Order of the Purple Hear, together with Cleburne's Allmon-Burgess Post #12152 Veterans of Foreign Wars have chosen to recognize the National Day of Recognition of the Purple Heart designated August 7, 2020 as a day to Remember, Recognize and Honor Purple Heart Recipients; and

WHEREAS, Johnson County has over 14,000 veterans many of whom are Purple Heart Recipients and the organizations herein named wish to pledge strong support for these noble organizations and for those who put their lives at risk in service of their Country and their fellow citizens.
