PROCLAMATION

STATE OF TEXAS

NATIONAL POW/MIA RECOGNITION DAYS

WHEREAS, the third Friday of each September has been nationally recognized as POW/MIA Recognition Day since 1979 to commemorate the Prisoners of War and Missing in Action military personnel whose whereabouts remain unknown; and

WHEREAS, this day is recognized throughout the nation and around the world on military installations, ships at sea, state capitols, schools, churches, national veteran and civic organizations, police and fire departments, fire stations, Federal buildings and the American Legion Auxiliary Unit, Post and Squadron 50 in Cleburne together with the other Veterans Service Organizations in Johnson County; and

WHEREAS, the remains of many Korean and WWII servicemen have been identified and are being returned home to their families and an estimated 32,000 former POWs live among us nationally and World War II MIA are almost 72,327; 7,648 missing from the Korean War; 1587 are unaccounted for from the Vietnam War and the number from our current war changes daily; and of the total 81,562 POW/MIA, almost 2000 are from Texas; and

WHEREAS, we wish to pay tribute to former POW/MIA personnel in our midst and to the service members who have not returned from the battlefield; to stand beside their families and honor those who are held captive as prisoners of war while we pledge to never forget their sacrifice, nor ever abandon our responsibility to do everything in our power to bring them home to their families; and

WHEREAS, Cleburne's patriotic citizens realize our work is no finished until our heroes are returned safely to our shores or a full accounting is provided to their loved ones and further desire to participate in the national POW/MIA Recognition Day inasmuch as there are families in Cleburne that still await knowledge of their loved-one's whereabouts since as long ago as World War I; and


WHEREAS, Cleburne American Legion Post, Auxiliary Unit and S.A.L will host a ceremony at 313 West Chambers for the purpose of remembering and honoring these heroes;


NOW THEREFORE BE IT RESOLVED THAT I, Roger Harmon, County Judge of Johnson County, together with the Commissioners Court hereby proclaim participation of September 14-18, 2020 in observance of


"NATIONAL POW/MIA RECOGNITION DAYS"


