Assistant Auditor, Internal Auditor (part-time), Susan Rossee, wage of \$25.51 per hour.



The above salaries are to be paid in equal bi-weekly installments out of the General Fund of Johnson County, Texas, effective October 1, 2020.







The above salaries are to be paid in equal bi-weekly installments out of the General Fund of Johnson County, Texas, effective October 1, 2020.



Johnson County will provide stenograph paper and exhibit stickers for all Deputy Official Court Reporters. Deputy Official Court Reporters will provide their own audio tapes and computer disks.

Johnson County will pay mileage for Deputy Official Court Reporter in the amount set by the Commissioners Court for Johnson County employees per County Policy.

INDIGENT CRIMINAL APPEALS

Official Court Reporters and Deputy Official Court Reporters shall be paid \$5.50 per page for an original and two copies on all indigent criminal appeals. Copies of exhibits will be compensated for at the rate of 60 cents per page. The cost of binders and binding, as well as deliveries, will be included in the above per page rates. All postage costs will be reimbursed to the Court Reporters in all indigent appeals.
