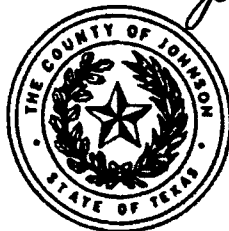

**ORDER APPOINTING PURCHASING AGENT**

On the 2<sup>nd</sup> day of September 2020, the District Judges of the 18<sup>th</sup>, 249<sup>th</sup>, and 413<sup>th</sup> Judicial Districts, the Johnson County Judge, and the Commissioner of Precinct Number 4, in compliance with Local Government Code Section 262.011, hereby appoint Ralph McBroom as Purchasing Agent of Johnson County, Texas for a two-year term of office beginning July 7, 2020 and ending July 6, 2022.

It is further Ordered that during his appointment as Purchasing Agent his annual salary shall be in the amount of \$75,186.00 per year, payable in equal bi-weekly installments. It is further Ordered that he shall be paid additional compensation of \$3,744.00 annually for travel allowance. The travel allowance shall be paid on the first and second pay periods of each month in the amount of \$156.00. It is further Ordered that he shall be paid a cell phone allowance of \$40.00 per month. In addition, he shall receive the same salary increase and/or additional salary payment, if any, authorized by the Commissioners Court to be paid by Johnson County for the 2020-2021 fiscal year.

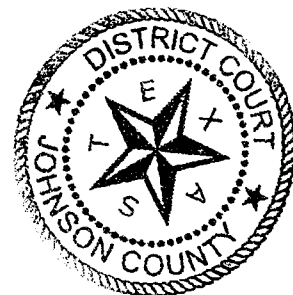

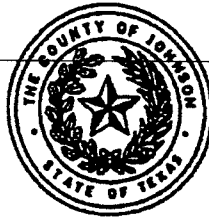

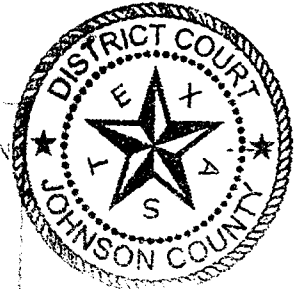
