JJAEP - Added 2% increase (\$746) to Part Time line (0330-5980-51070-AJ)

Added Stipend line to Sheriff's budget (0100-5600-51055-LE). Position C05-009 budgeted for \$62,842 was reclassed to a Deputy Position D03-070 budgeted at \$56,042. The \$6,800 difference was added to the Stipend line budget. Adjusted fringe as needed.

Sheriff's Office – Added \$600 to Certification Pay line (0100-5600-51045-LE) for position D03-032. Increased SO Salaries Line (0100-5600-51030-LE) \$7due to rounding differences and adjusted fringe as needed.

Sheriff's Office – Added \$21,333 to Small Tools & Supplies line (0100-5600-53300-LE) Riot Gear that was ordered in FY 2020 won't be received by 9/30/2020
