COMMISSIONERS COURT GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT STRYKER PROVIDING THE LUCAS® CHEST COMPRESSION SYSTEM IS A PRODUCT THAT CAN BE OBTAINED FROM ONLY ONE SOURCE

The Johnson County Commissioners Court met on September 28, 2020, in regular session for the consideration that the product, the Lucas® Chest Compression System, is a product that can be obtained from only one source. The Commissioners Court finds that the product, the Lucas® Chest Compression System, is a product that can be obtained from only one source, and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code as no other company, other than Stryker, provides the product of the Lucas® Chest Compression System.

A motion was made by Commissioner Stringer, Pct. #3 and seconded by Commissioner Woolley, Pct. #4 that: "The Commissioners Court finds that that the product of the Lucas® Chest Compression System provided by Stryker is a product that can be obtained from only one source, and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code as no other company provides the Lucas® Chest Compression System".

Said motion was approved by a vote of the Commissioners Court on the 28th day of September, 2020.

NOW THEREFORE BE IT RESOLVED AND ORDERED:

The Commissioners Court of Johnson County, Texas does hereby enter this order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that the product of the Lucas® Chest Compression System provided by Stryker is a product that can be obtained from only one source.


