COMMISSIONERS COURT

BE IT KNOWN that on the 14th day of December 2020, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:01 A.M. with all members present, and following the Invocation led by County Judge, Roger Harmon, and the Pledge of Allegiance, the following items, having been lawfully posted and filed for record in the Office of the County Clerk on December 10, 2020 at 1:05 P.M. with an Addendum filed on December 10, 2020 at 3:53 P.M. were considered.

IV. WELCOME VISITORS, ANNOUNCEMENTS & PRESENTATIONS

County Judge, Roger Harmon thanked guests for coming out. He also commented on and asked for prayers for the passing of two friends. One of which being Bob Summers, a mutual friend of his and Johnson County Auditor, Kirk Kirkpatrick.

1. <u>DUE TO THE CHRISTMAS HOLIDAYS, THE DEADLINE TO SUBMIT ITEMS FOR THE DECEMBER 28, 2020 COMMISSIONERS COURT AGENDA WILL BE NOON ON MONDAY, DECEMBER 21, 2020</u>

County Judge, Roger Harmon announced that due to the Christmas Holidays, the deadline to submit items for the December 28, 2020 Commissioners Court Agenda will be Noon on Monday, December 21, 2020.

2. PRESENTATION OF RETIREMENT PLAQUE TO DEBRA DECKER, TAX OFFICE

Jonson County Tax Assessor-Collector, Scott Porter and the Members of the Commissioners Court presented a Retirement Plaque to Debra Decker, Tax Office for her 42 years of service to Johnson County.

V. PUBLIC HEARING

The Commissioners Court opened a Public Hearing at 9:14 A.M. to discuss:

1. PUBLIC HEARING TO REVISE THE PLAT OF BLUE BIRD WOODS, BY REVISING LOTS 3 AND 4 TO FORM LOTS 3R AND 4R, IN PRECINCT #4

There being no one from the Public wishing to speak, County Judge, Roger Harmon turned the discussion over to Comm. Woolley, Precinct #4.

Comm. Woolley commented that this was a revision to move a couple of lot lines.

Public Works Director, David Disheroon commented that all requirements had been met.

There being no one else to speak, the Public Hearing was closed at 9:16 A.M.

The Commissioners opened a Public Hearing at 9:16 A.M. to discuss:

2. PUBLIC HEARING TO REVISE THE PLAT OF THE HOMESTEADS, BY REVISING LOT 34 TO FORM LOTS 34A, 34B AND 34C, IN PRECINCT #3

There being no one from the Public wishing to speak, County Judge, Roger Harmon turned the discussion over to Comm. Stringer, Precinct #3.

Comm. Stringer commented that the piece of land was being broken into three separate lots and all requirements had been met.

There being no one else to speak, the Public Hearing was closed at 9:17 A.M.

The Commissioners Court opened a Public Hearing at 9:17 A.M. to discuss:

3. PUBLIC HEARING TO REVISE THE PLAT OF THE RANCHES AT EAGLE RIDGE, BY COMBINING LOTS 23 AND 24 INTO 23R, IN PRECINCT #1

There being no one from the Public wishing to speak, County Judge, Roger Harmon turned the discussion over to Comm. Bailey, Precinct #1.

Comm. Bailey commented that there was no one here to speak about it, but it was good to get everything going.

There being no one else to speak, the Public Hearing was closed at 9:18 A.M.

The Commissioners Court opened a Public Hearing at 9:18 A.M. to discuss:

4. PUBLIC HEARING TO CONSIDER CLOSING A PORTION OF SOUTH HAMPTON ROAD LOCATED SOUTH OF THE BOUNDARY LINE BETWEEN TARRANT COUNTY AND JOHNSON COUNTY AND NORTH OF EDGEHILL ROAD LOCATED IN UNINCORPORATED JOHNSON COUNTY, TEXAS BETWEEN THE CITY OF BURLESON AND THE CITY OF CROWLEY

Alethea Galke addressed the Court in regards to closing the road North of Edgehill. She commented that she and many others use that area to walk and that closing the road would force walkers to go down John Jones where there are no sidewalks. She requested that the Court at least leave the road open to walkers.

Mark Wells addressed the Court in regards to closing the road. He commented that he is one of the property owners in that area and that the road has been unofficially closed for 10 plus years. He said it was his hope to close officially and put in a walking trail. Wells also commented that that area is somewhat isolated and they have issues with people parking and dumping trash. He stated that the County has not been maintaining that area, but that the City of Crowley and the property owners do. He requested that the road be sectioned off for no motor vehicles.

County Judge, Roger Harmon commented that he believed the City of Burleson had put a barricade across their side of the road. He also commented that it was his understanding that when the County closes a road, the respective landowners split the road.

County Attorney, Bill Moore responded to the County Judge stating that he believed the Judge's comment was correct.

Judger Harmon noted that he did not know what Mr. Wells's intentions were with his section of the land, but that it would be his decision if the Court approved to close the road.

Wells commented that he had not talked to the other property owner and he did confirm that the barricade had been there for 10 to 15 years.

Comm. Howell commented that there were two property owners involved. He also confirmed that the County has never maintained the road and that he did not even realize it was a County Road because it is surrounded by the City of Crowley and the City of Burleson. Comm. Howell commented that he was concerned that the road could be a liability for the County due to the condition of the road. He stated that the road is almost not there and that it is more of an alleyway. Comm. Howell stated that he recommended closing the road, because he didn't want to spend taxpayer money to maintain a road that is not accessible by traffic.

Comm. Bailey commented that it would be up to the property owners to decide what would happen to the land if the road were closed; but that it sounded like closing the road was not going to change anything. He also commented that if the landowners wanted to put in a walking trail that they could possibly reach out to one of the Cities for assistance.

There being no one else to speak, the Public Hearing was closed at 9:30 A.M.

The Commissioners Court opened a Public Hearing at 9:30 A.M. to discuss:

5. PUBLIC HEARING TO "REDUCE SPEED LIMIT TO 20 MPH" ON CR 316-A/WEEKS RD./MALONE RD. FROM CLEBURNE CITY LIMITS TO END OF CR 316-A/WEEKS RD./MALONE RD. IN JOHNSON COUNTY, TEXAS

There being no one from the Public to speak, County Judge, Roger Harmon turned the discussion over to Comm. Woolley, Precinct #4.

Comm. Woolley commented that this was a dead end road and that it was very narrow and winds around. He stated that although it is technically a 40 MPH road that you cannot get up to 20 MPH. Comm. Woolley stated that this is a safety thing.

There being no one else to speak, the Public Hearing was closed at 9:32 A.M.

VI. PUBLIC PARTICIPATION

Brenda Gammon, an Election Judge, addressed the Court in regards to elections. She thanked the Court for their support and commented that this was the hardest election year ever. She stated that they needed the Court's help for future elections. Gammon commented that they need a better area for the handicapped and 65 years and older voters, more election clerks, more locations in Burleson for early voting, better machines and poll watchers at every location.

Comm. Bailey commented that they are going to have to work hard to get people out to go vote since people feel like their vote will not be counted properly.

Gammon commented that she thought many people are paying attention and realizing their vote matters.

County Judge, Roger Harmon stated that the Court normally does not make comment, but that this was a perfect storm. He also thanked Comm. Howell for his efforts in extending the parking lot at the Burleson Sub-Courthouse.

Alethea Galke did not address the Court because she had previously spoken during a Public Hearing.

Al Betzel addressed the Court in regards to the property at 6100 N. F.M. 157. He stated that this property had been turned into a rodeo and that it's a safety concern for the surrounding property owners. He commented that there are noise, traffic, trash, violence concerns and that he was afraid of retaliation if the owners of the rodeo found out he was here. Betzel also commented that he has made modifications to his own property to try and counteract some of the issues with the rodeo. He stated that the rodeo was not practicing social distancing and people were not wearing masks. He thanked the Sheriff's Office for their efforts this past weekend.

Jim Robertson addressed the Court in regards to the rodeo on F.M. 157. He commented that there was a serious problem out there. He stated the amount of traffic prevents emergency vehicles from responding and that cars are pulling in ditches, sitting and firing gunshots.

Robertson stated that there are many families out there that are in danger and confined on their own property with kids not allowed to play in the front yard. He thanked the Sheriff's Office for their help and said that they did run a lot of them off.

County Judge, Roger Harmon commented that the Court was very much aware of the issue out there.

Carey Nelson addressed the Court in regards to the danger from Lienzo el Tejano. He stated that he owns the property directly south and north of the rodeo and that the noise is unbearable. He stated that he has recorded noise up to 100 decibels. Nelson said he has called the Sheriff's Office numerous times, but as soon as the Deputies leave, the noise goes right back up. He commented that there is trash, parking in ditches, parking in people's front yards, public urination, drinking, trespassing, gun violence and animal cruelty. He stated that he has tried to contact the owner personally with no response. Nelson stated the rodeo was a danger to the community.

Judge, Harmon thanked everyone for coming out to voice that issue.
