**At Sub-Courthouse - Curbside voting. Only 1 clerk went to**

**they weren't in the computer and couldn't get thru to Elections ofc Yikes! People told me that too!**

**I'm not just complaining. I have ideas.**

**Judges need to be paid more, have more help, better training - have more say over their clerks, etc. Gotta!**

**For instance, My Alternate Judge and all the Democrat clerks - ok most dem clerks - did not do training.**

**Mine were told (they told me) they were told by Linda Brown they didn't need training!  
BIG problem! I had to teach them that day - all day.**

**My municipal Judge and her clerks were not trained so I also had to train them. 🤔**

**Meanwhile I'm having to meet with every 12 voters or so I**
