RE: Sale of Weapon to Retiring Officer Tim Kinman

Hon. Judge and Commissioners:

Section 614.051 of the Government Code states that an honorably retired peace officer may purchase the firearm that had been previously issued to him(her) for an amount not to exceed fair market value.

Sec. 614.051. PURCHASE OF FIREARM BY HONORABLY RETIRED PEACE OFFICER.

- (a) An individual may purchase a firearm from a governmental entity if:
 - (1) the individual was a peace officer commissioned by the entity;
 - (2) the individual was honorably retired from the individual's commission by the entity;
 - (3) the firearm had been previously issued to the individual by the entity; and
 - (4) the firearm is not a prohibited weapon under Section 46.05, Penal Code.
- (b) An individual may purchase only one firearm from a governmental entity under this section.

In order for deputies, currently retiring, to proceed with the purchase of the county-issued firearm, the following price(s) are considered to be in compliance with the statute.

Sig Sauer P320, 9mm - \$325.00

The amount reflects a price that does not exceed fair market value; something close to a trade-in value.
