COMMISSIONERS COURT

BE IT KNOWN that on the 4<sup>th</sup> day of January 2021, the Honorable Commissioners Court of Johnson County, Texas, met in Special Session at the Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:02 A.M. (County Judge, Roger Harmon stated the time as 9:03 A.M.) with all members present, and the following items, having been lawfully posted and filed for record in the office of the County Clerk on December 31, 2020 at 10:56 A.M. were considered:

**I. NEW BUSINESS**

**1. SWEARING IN OF NEWLY ELECTED OFFICIALS FOR JOHNSON COUNTY, TEXAS-COUNTY JUDGE**

County Judge, Roger Harmon thanked everyone for coming. He commented that due to the Coronavirus, the Court was unable to hold a traditional Swearing in Ceremony. Judge Harmon stated that the Elected Officials that were new to office were sworn in on January 1, 2021 at midnight.

Judge Harmon swore Commissioner Rick Bailey, Precinct #1, County Attorney, Bill Moore and Johnson County Tax Assessor-Collector, Scott Porter into office. He noted that Constable Steve Williams, Precinct #3 and Constable Troy Fuller, Precinct #4 were sworn in Thursday at midnight by their respective Judges. Judge Harmon commented that the County has a good team of Elected Officials and Department Heads.

Constable Steve Williams, Precinct #3 addressed the Court and gave thanks to God, his wife and the people for electing him. He commented that being elected was very humbling and that he hoped to do as well as his predecessor, Commissioner Mike White, Precinct #3.

Constable Troy Fuller, Precinct #4 addressed the Court and commented that he was proud and thankful to the citizens who elected him. He stated that he planned to be the best he could while in office. He noted that he had a long standing relationship with the Court and he plans to continue that.

Commissioner Mike White, Precinct #3 addressed the Court and thanked God, his family and the citizens. He stated that he looked forward to working with the Court and trying to do good for the County.

18<sup>th</sup> District Judge, Sydney B. Hewlett commented that she was glad she was able to be here today.

2. CONSIDERATION TO EXTEND THE AVAILABILITY TO USE THE EMERGENCY PAID SICK LEAVE (80 HOURS) ESTABLISHED UNDER THE FAMILIES FIRST CORONAVIRUS RESPONSE ACT (FFCRA) TO MARCH 31, 2021

Comm. Bailey, seconded by Comm. White, made a motion to approve to Extend the Availability to use the Emergency Paid Sick Leave (80 Hours) Established under the Families First Coronavirus Response Act (FFCRA) to March 31, 2021.

All voted aye; motion carried.

1. Government Code:


a. *Section 551.071, Personnel*
