

Service Agreement to Remove Unauthorized and Illegal Parking

This agreement between **Johnson County, Texas** (company name) and Beard's Towing, LLC located in Johnson County, Texas witnesses that:

- 1) Beard's Towing agrees upon authorization from an authorized agent of **Johnson County, Texas** will pick up and remove abandoned, illegally or improperly parked vehicles from the premises at **102 S. Mill Street, Cleburne, Texas 76033** (address) owned or operated by **Johnson County, Texas** (company name).
- 2) All vehicles with a GVWR of 10,000 and under removed shall be stored in a safe and secure lot at 4505 Cross Timber Rd., Burleson, Texas 76028. All vehicles with a GVWR of 10,001 and over shall be stored in a safe and secure lot at 4450 E Loop 820 S., Fort Worth, Texas 76119. Beard's Towing agrees to act as agent for **Johnson County, Texas** in disposing vehicles not redeemed by the registered owner and/or lien holder, in order to satisfy accrued charges. Beard's Towing agrees to follow all laws set forth by the State of Texas pertaining to abandoned, junked and/or unauthorized, illegally parked vehicles; Article V-(v.c.s 4477-9a) Texas litter abatement act....(V.C.S. 6687-9) Texas abandoned motor vehicle act....(V.C.S. 6701 F-2) Texas motor vehicle laws.
- 3) No charge will be made to **Johnson County, Texas** (company name) by Beard's Towing for the services described in paragraph 1 above. The owner of the vehicle shall be charged up to but not exceeding the maximum allowed private property towing charge as set forth by the State of Texas for the towing, \$20.64 per day for the storage plus tax for vehicles up to 25 ft in length and \$36.11 for vehicle over 25 feet in length plus tax, \$20.64 plus tax impound fee and \$50.00 notification fee.
- 4) This agreement is for a period of one (1) year and will be automatically renewed in one (1) year increments. This agreement may not be changed or cancelled during the contract year period, but can be cancelled or amended at the end of the contract year thirty (30) days before it renews.
