## FOUR CHAPLAINS DAYS OF UNITY

- WHEREAS, February 3, 2021, will mark the seventy-eighth anniversary of the sinking of the troopship DORCHESTER, which carried to their deaths four Chaplains of three faiths who stood united in prayer as the ship went down; and

- WHEREAS, The heroic deed of the four Chaplains and their combined act of supreme devotion, unity and sacrifice for American liberty and human freedom will be an inspiring and ever shining example of real brotherhood for all time to the people of the world; and
- WHEREAS, The American Legion Auxiliary, The American Legion and the Sons of the American Legion annually honor in remembrance of the unity and the unselfishness demonstrated by these Four Chaplains; and
- WHEREAS, We must all see to it that their supreme sacrifice to the cause of human freedom and justice for all shall not have been made in vain;
