BE IT KNOWN that on the 1st day of March 2021, the Honorable Commissioners Court of Johnson County, Texas, met in Special Session at the Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M. with all members present, and the following items, having been lawfully posted and filed for record in the office of the County Clerk on February 25, 2020 at 1:06 P.M. were considered:

County Judge, Roger Harmon opened the meeting with a word of prayer.

I. NEW BUSINESS

1. CONSIDERATION TO APPROVE AMENDMENT OF FACILITY OPERATION AND MANAGEMENT SERVICES AGREEMENT BETWEEN JOHNSON COUNTY, TEXAS AND LASALLE CORRECTIONS, LLC THAT WAS EFFECTIVE SEPTEMBER 1, 2015-COUNTY JUDGE'S OFFICE

Comm. Bailey, seconded by Comm. Woolley, made a motion to approve the Amendment of Facility Operation and Management Services Agreement between Johnson County, Texas and Lasalle Corrections, LLC that was Effective September 1, 2015 and to give County Judge, Roger Harmon and Sheriff, Adam King the authorization to sign-County Judge's Office.

All voted aye; motion carried.

2. UPDATE ON THE WINTER STORM OF FEBRUARY 2021-COUNTY JUDGE'S OFFICE

Johnson County Emergency Management Coordinator, Jamie Moore gave an update to the Court in regards to the Winter Storm of February 2021.

Josh Green, Public Works Special Projects Manager addressed the Court to discuss all the damage done to the County buildings by the Winter Storm.


