1. CONSIDERATION OF AMENDMENTS TO THE 2020-2021 COUNTY
BUDGET REGARDING EXPENDITURES FOR THE OPERATION AND
MANAGEMENT OF THE JOHNSON COUNTY JAIL BY THE JOHNSON
COUNTY SHERIFF FOR THE MONTH OF SEPTEMBER 2021 PURSANT TO
SECTION 111.010 OF THE LOCAL GOVERNMENT CODE UPON THE
COMMISSIONERS COURT FINDING THAT AN EMERGENCY EXISTS IN
