**ORDER AUTHORIZING MEMORIAL DAY FIREWORKS SALES**

---

The Johnson County Commissioners Court met on April 12, 2021 in regular session for the consideration of authorizing Memorial Day fireworks sales in Johnson County.

**WHEREAS**, the Commissioners Court of Johnson County is authorized under Occupations Code Section 2154.202(h), to issue an order allowing retail fireworks permit holders to sell fireworks to the public in celebration of Memorial Day; and

**WHEREAS**, on the 12<sup>th</sup> day of April, 2021 the Commissioners Court of Johnson County has determined that conditions are favorable to issue such an Order:

**A motion was made by Commissioner \_\_\_\_\_ and seconded by Commissioner \_\_\_\_\_ that:** The Commissioners Court of Johnson County adopts this order authorizing the sale of fireworks to the public by retail fireworks permit holders during the Memorial Day period beginning Wednesday, May 26, 2021 and ending at midnight Monday, May 31, 2021, subject to the following restrictions:

- a. This order expires on the date the Texas Fire Service determines drought conditions exist in the county or midnight, Monday, May 31, 2021, whichever is earlier.

Said motion was approved by a vote of the Commissioners Court on the 12<sup>th</sup> day of April, 2021.

**NOW THEREFORE BE IT RESOLVED AND ORDERED:**  
The Commissioners Court of Johnson County, Texas does hereby enter this order authorizing Memorial Day fireworks sales beginning Wednesday, May 26, 2021 and ending at midnight Monday, May 31, 2021.
