Please consider the following pertaining to the Johnson County Jail:

- The purchasing of (200) handcuffs, (200) belly chains, (200) shackles, batons, baton holders, and (64) radios.
- The purchasing of (58) LifeCheck scanners including a one-time licensing fee.
- The purchasing of inmate clothing, mattresses, blankets, pillows, etc.
- The purchasing of maintenance tools and supplies, less (2) shipping containers.
