ORDER APPOINTING COUNTY AUDITOR


On the 7th day of May 2021, the undersigned District Judges of the 18th, 249th, and 413th Judicial Districts, which districts serve Johnson County, Texas, hereby appoint Steven Edward Watson as Johnson County Auditor for a biannual term beginning June 1, 2021 and ending on May 31, 2023.


It is further ordered that said Auditor shall be paid an annual salary of \$135,926.00 and a travel allowance of \$6,739.00, payable in equal biweekly installments and a monthly cell phone allowance of \$80.00 being the same salary and benefits as currently approved and ordered for the former County Auditor and administered along with benefits as all other public officials

It is further ordered that this action shall be recorded in the minutes of the District Courts of Johnson County, Texas and the District Clerk of Johnson County is hereby directed to certify same to the Commissioners Court of Johnson County, Texas and said Commissioners Court shall cause the same to be recorded in its minutes.


