BE IT KNOWN that on the 28th day of June 2021, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:01 A.M. with all members present, and following the Invocation led by County Judge, Roger Harmon, and the Pledge of Allegiance, the following items, having been lawfully posted and filed for record in the Office of the County Clerk on June 24, 2021 at 1:13 P.M. were considered.

IV. WELCOME VISITORS, ANNOUNCEMENTS & PRESENTATIONS

County Judge, Roger Harmon welcomed the guests in the audience and thanked them for being at today's meeting.

County Judge, Roger Harmon announced for Court Record that the regularly scheduled Commissioners Court Meeting for July 12, 2021 has been rescheduled for July 9, 2021 at 9:00AM, and that the deadline to submit items for the July 9, 2021 Agenda will be Noon, June 30, 2021.
