COMMISSIONERS COURT

BE IT KNOWN that on the 9th day of July 2021, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M. with all members present, except for County Judge, Roger Harmon; Commissioner Rick Bailey, Precinct #1 presided, and following the Invocation led by Comm. Bailey, Pct. #1 and the Pledge of Allegiance, the following items, having been lawfully posted and filed for record in the Office of the County Clerk on July 2, 2021 at 3:08 P.M. were considered.

IV. WELCOME VISITORS, ANNOUNCEMENTS & PRESENTATIONS

The Commissioners Court observed a moment of silence for Monte Swatzell.

Comm. Bailey announced the Texas Well Owner Network Training and Well Water Testing Scheduled for July 21 - 22, 2021 at the Trinity River Authority of Texas Office in Arlington, Texas. Sample Containers and Collection Instructions May be Picked up at the Precinct #4 Commissioners Office or the Johnson County AgriLife Extension Office Prior to those Dates.

Comm. Woolley, Pct. #4 commented that this is a follow up to the previous testing done by Prairielands. He noted domestic water well users could have their water tested for contaminants at no cost. Comm. Woolley stated that the samples must be turned in by 9:00 A.M. on July 21, 2021 to either the Precinct #4 Commissioners Office, or the County Agrilife Extension Office.

Comm. Bailey turned the discussion over to Comm. Woolley, who had no comment.

Public Works Director, David Disheroon addressed the Court and commented that the developer had met all the requirements, and are ready to move forward.

Comm. Bailey closed the Public Hearing at 9:08 A.M.

Comm. Woolley commented that there were individuals from the Public that wanted to speak.

Since the Public Hearing had already been closed, Comm. Bailey moved to Public Participation in order to allow those who wished to speak in regards to the Public Hearing for the revision of the Plat of Crystal Palace Estates to do so.

VI. PUBLIC PARTICIPATION

Tami Ratteree addressed the Court in regards to flooding and drainage in Johnson County,
Precincts #3 and #4. She specifically addressed an electrical pole in a drainage area.

Coretta Woodward addressed the Court in regards to putting in 80 homes. She stated she had safety concerns about the amount of traffic that would be on a small 2-lane road if all 80 homes were built. She commented that she moved to that area after retirement for the peace and quiet, she stated that she did not want the revision of the plat to go through.

Betsy Hathaway addressed the Court in regards to putting in a Subdivision and expanding Crystal Palace Estates. She stated she was representing four additional families that could not attend the Meeting. She commented she was concerned about 11 homes being on a quarter mile road and about the new homes ruining the peace and quiet that she moved there to get.

June Todd addressed the Court in regards to the revision of the plat of the Subdivision in **Crystal Palace Estates**. She stated she has property adjoining the **Crystal Palace Estates** and was concerned about the habitat for wildlife and space if 80 homes are built. She commented she was concerned about an old well on the property that may have been there for years that they would fill in. She also mentioned that she was aware of some Subdivisions in Tarrant County and Mansfield that oversold and had a series of foreclosures, and she did not want to see that happen here.

Joel Jackson addressed the Court in regards to **Crystal Palace Estates**. He stated he had safety concerns as well as concerns about how this would impact the environment. He asked the Court to postpone approving the new revision to allow the community time to research what was going to be done.

Valentina Ramirez addressed the Court in regards to Crystal Lane. She stated she is concerned of the further increase in traffic if the homes are built because she stated she has already experienced an increase in traffic since the Louis Vuitton factory went in. She also commented that her family picked that area for the peace and quiet.

Tommy Woodward addressed the Court in regards to housing development. He stated that he has been a resident of **Crystal Palace Estates** for 11 years. He commented that he was concerned about the traffic that will happen if additional houses are built, the disturbance of the peace and quiet, and he also expressed concern for the wildlife.
