This Price Quote is for the Johnson County Sheriff's Office ("Johnson County"), and the following terms, as well as any online terms and conditions, apply to the implementation and use of the Life Check Systems ("LCS") technology at the detention facility specified below:

Bed Capacity: 564

- 1. Software Licensing Fee. Johnson County will pay a one-time software license fee of \$1.00 covering lifetime system use and future upgrades.
- 2. Monthly Service Fee. Starting on September 1, 2021, Johnson County will pay \$1,500 per month to LCS for continuous system maintenance, software upgrades, tech support, cellular service, website storage, etc., plus \$6 per device over 57 devices. For example, if Johnson County adds 10 devices for a total of 67, the monthly cost will increase by \$60 (\$6.00 x 10 devices) to a total of \$1,560 per month.
- 3. Cost of Mobile Devices. Johnson County purchased approximately 57 LCS devices from LaSalle Corrections who previously used the system at the facility, and Johnson County can continue to use those devices. Johnson County may also purchase devices for \$675 per device, and payment due when devices are ordered.
- 4. Additional Equipment Costs. LCS sells this equipment at these prices, but all prices are subject to change at any time:
 - Location Tags \$3.00
 - 3-Bay Wireless Charger \$50
 - 1-Bay Wireless Charger \$20

- Magnetic Holsters \$75
- Belt-clip Holsters \$35
- Mobile Devices \$675
- 5. Shipping & Taxes. Johnson County will pay LCS's shipping costs and any taxes required.
- 6. Location Tags. Johnson County will use the location tags installed in the facility, and can purchase more as needed.
- Term & Automatic Renewal. The agreement term is 3 years from the date Johnson County takes 7. over jail operations from LaSalle Corrections, and it will automatically renew for an additional term of the same length, unless Johnson County notifies LCS in writing before the end of the original term that the County does not want to renew the contract.

- Warranty, LCS warranties new mobile devices for one-year for any defects other than physical 8. damage. All devices Johnson County purchased from LaSalle are excluded from this warranty. LCS disclaims all other warranties, express or implied.
- 9. LCS Organization Administrator. Johnson County will designate an LCS Administrator, who will learn the administrative functions, be the point of contact with LCS, and train all other personnel. LCS will provide free online training to the LCS Administrator.
- Wi-Fi Requirements & Information. LCS requires a reliable internet connection to function. LCS 10. does not provide Wi-Fi. Johnson County shall provide a reliable Wi-Fi network to serve as the primary internet connection.
- 11. Backup Cellular Connection. LCS provides a cellular connection to Verizon's 4G and LTE Networks as a backup internet connection only. Johnson County shall identify areas with weak Verizon coverage and install boosters as desired. LCS does not install boosters.
- 12. Cellular Data Cost. LCS will pay Verizon data charges from the County's devices up to \$100 per month, which Johnson County should never exceed so long as Wi-Fi is the primary internet connection. However, LCS may charge Johnson County for data exceeding \$100 per month.
- 13. Offline Operation & Alerts. LCS cannot provide accurate alerts without an internet connection. The Special Watch function does not work without a connection. The Security Inspection and General Observation functions will continue to operate with no connection by locally storing data and uploading it when a connection is restored. With no connection, there will be false alerts and neither devices nor the website will update until a connection is restored.
- 14. Tech Support. LCS will provide technical support free of charge through its online 'Report a Problem' function.
