COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON

THE COMMISSIONERS COURT FINDING THAT THE MEDICAL SERVICES PROVIDED BY TLC TRAVEL STAFF LLC ARE PROFESSIONAL SERVICES

The Johnson County Commissioners Court met on August 23, 2021 in regular session for the consideration of a contract between Johnson County, Texas and TLC Travel Staff LLC, and the Commissioners Court finds that this contract is for professional services and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.

A motion was made by Commissioner Howell, Pct. #2 and seconded by Commissioner White, Pct. #3 that: "The Commissioners Court find the contract for medical services provided by TLC Travel Staff LLC is a contract for professional services and that the Commissioners Court grants an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code, and enter an order to that affect, and that the Commissioners Court approve the contract for medical services with TLC Travel Staff LLC."

Said motion was approved by a vote of the Commissioners Court on the 23<sup>rd</sup> day of August, 2021.

## NOW THEREFORE BE IT RESOLVED AND ORDERED:

The Commissioners Court of Johnson County, Texas does hereby enter this order granting an exemption under Section 262.024, Local Government Code, from the bidding requirements of Section 262.023, Local Government Code, upon the Commissioners Court finding that the contract for medical services with TLC Travel Staff LLC is a contract for professional services.
